According to Jim O'Neill, Entegris' senior vice president and chief technology officer, "With the SDMTC, we are in a strong position to develop new digital capabilities and co-innovate new solutions that can be applied to Entegris' products for its global customers in the semiconductor industry. This will translate into faster time to solution as well as faster time to yield," he said.

The SDMTC will be fully digital, and all major phases in the R&D product development cycle from idea generation to testing and validation will be digitalized. The SDMTC's ability to handle large volumes of data will create a digital thread that connects the characteristics of raw materials to the performance metrics of final products.
